*Mayor Howard asked the Council whether or not the City would participate in the Weather Preparedness Tax Holiday. Councilman Ray made the Motion for the City to participate in the Weather Preparedness Tax Holiday. Mayor Pro-Tem McIntyre seconded the Motion. The Motion passed unanimously.*

*Debra Lily's road was next on the Agenda. Mr. Barker researched it and the is not a road and it has not been accepted by the City of Margaret. Ms. Lily's road is a private drive. The City Clerk will send a letter to Ms. Lily explaining that the road is not a road accepted by the City of Margaret and that the City does not have a right away. Therefore, the City can only patch the holes along the main road.*

*Ms. Brown submitted a variance to put a mobile home on Polo Lane. Mr. Barker stated that he viewed pictures of the mobile home and they were nice. Mr. Barker also explained to Ms. Brown that the pictures must be a true image of the mobile home.*

*Mr. Barker gave his report to the Council. The total revenue for*

*A concerned resident of Hunter's Crossing asked the Council whether or not anyone checked to make sure the County has met the specs on paving when the paved Hunter's Crossing? Councilman Perry informed the resident that the no City performs checks and balances when it comes to the County.*

*Councilman Chapman suggested that the Council keep an eye on the lots That Four Star have sold.*
