## **Discussion:**

Keith Hager informed the Council that the asphalt contract had been signed.

Keith Hager informed the Council that the pavilion at Dillard Park will demolished after August 9, 2025.

Keith Hager hopes to provide budget numbers for the water tower in the next couple of weeks.

Councilman Darius Crump seconded the Motion. The Motion failed due to a lack of a unanimous vote.

Councilman Darius Crump moved to approve the minutes of 7-1-2025 after the correction of Councilman James Chapman's status as both present and absent. Councilman James Chapman was absent. Councilwoman Sandra Cook seconded the Motion. The Motion passed with three yeses and two noes.
