Adoption of Agenda

Mayor Pro-Tem James Chapman moved to adopt Resolution 2025-0715 which appoints the city clerk, Teja McIntyre as the election manager because the mayor is a candidate in the upcoming elections. City Clerk explained her duties as an election manager:

- 1). To publish notice of the election. Section 11-46-22.*
- 2). To prepare lists of qualified voters (unless the mayor is a candidate). Sections 11-46-36; 11-46-37.*
- 3). To provide election supplies. Section 11-46-32.*
- 4). To prepare and provide ballots. Section 11-46-25.*
- 5). To provide absentee voting materials and ballots.*

Sections 11-46-25, and 11-46-31.

6). To notify election officials. Section 11-46-27.
